## INDIVIDUAL PLAN

An amenity plan that provides membership benefits to that specific amenity for a single individual in a household. All Single plans will automatically convert to Individual with this conversion.

## FULL PLAN (HOUSEHOLD)

An amenity plan that provides membership benefits to all eligible candidates living in a Big Canoe home (see amenity provisions for qualifications). All memberships previously in the Couples or Family categories will automatically convert into Full Membership.

\*The Big Canoe POA recognizes a Full Program to include and extend benefits to lot owner, spouse/spousal equivalent and dependent children 25 year of age or younger, who either reside with the member full-time or attend college on a full-time basis. Prices and benefits valid for the 2023 season and subject to review each year. Property owners must maintain program plan for a minimum of 12-months once initiated. Programs will automatically renew each year unless proper resignation requirements are fulfilled. Reinstating a program plan once resigned may require a reinstatement fee. See amenity provisions and Amenity Manager for full details. All guests are expected to be accompanied by a Property Owner.

\*\* Any owner of property in the community whose primary residence is not in the state of Georgia or is at least 70 miles distance from the Big Canoe Main gate is eligible for an 'out of state' Wellness and Racquet Club membership. This entitles the authorized users of the membership to use all of the Wellness and Racquet Club amenities generally available for use by other Wellness and Racquet Club members. A copy of a current out of state drivers license is required for eligibility and must be kept on file in the POA Membership Director's office. If the primary residence changes, the membership will revert to a regular Wellness Center or Racquet Club Full-time membership.
